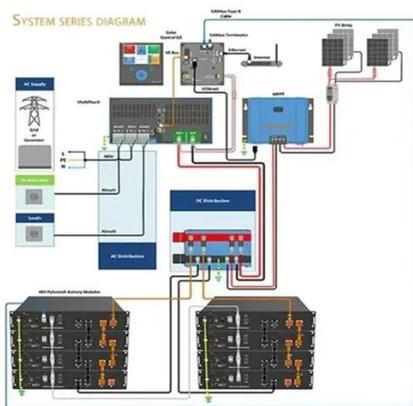

The energy industry is facing considerable uncertainty about the scope and expected implementation of the Executive Order<sup>1</sup> issued by the Office of the President on May 1, 2020 barring the importation or use of “bulk-power system equipment” in transactions involving a “foreign adversary” and risks to. By executive order, the secretary of energy is now authorized to review and block any acquisition, importation, transfer or installation of any bulk-power system electric equipment in which a foreign country or foreign person has an interest.


