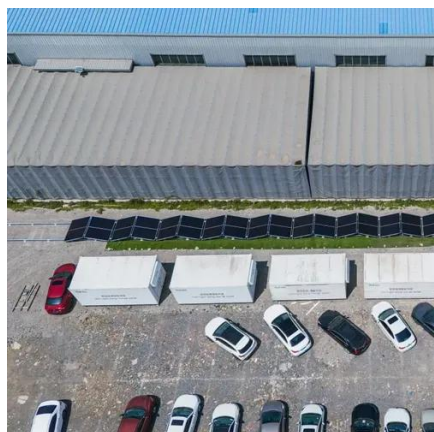

Working space shall be measured from the edge of the battery cabinet, racks, or trays. For battery racks, there shall be a minimum clearance of 25 mm (1 in.) between a cell container and any wall or ...
