You will need to file Form 5695, Residential Energy Credits when you file your tax return for year in which your residential energy property was put in service. Qualified expenses may. According to a 2023 industry report, over 20% of eligible homeowners miss out on this valuable credit or file for it. A REC is a tradeable, market-based instrument that represents the legal property rights to the “renewable-ness”—or all non-power attributes—of renewable electricity generation. The REC owner has exclusive rights to make claims about “using” or “being powered with” the renewable electricity. The federal government offers a solar tax credit known as the federal solar rebate. To claim this credit, you need to fill out IRS Form 5695.

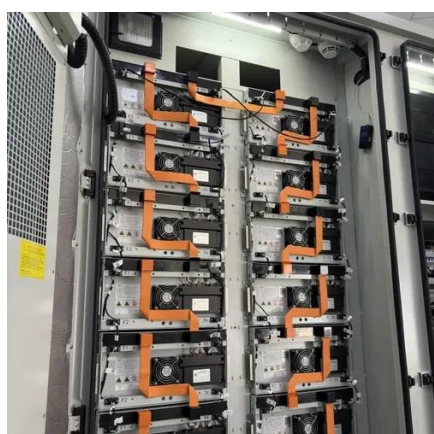
