What Is Solar Energy Export?

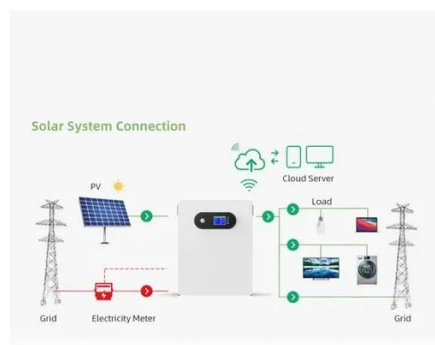

If you are considering applying for a tariff under the Small-Scale Renewable Support Scheme (SRESS) as a project exporting all electricity that you generate to the grid, we recommend following these initial steps: First, look at your site or building to see if it could work for a renewable energy. 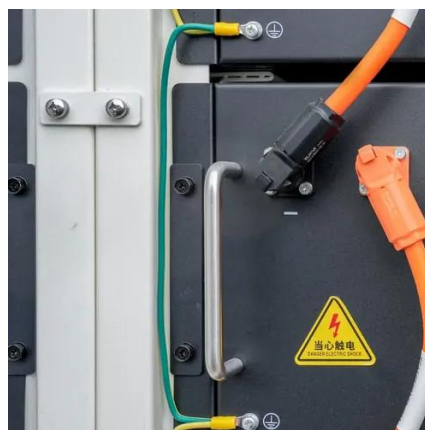
