



# Is it illegal to use photovoltaic panels on terrace roofs

Yes, solar panels that are found to be illegally installed can indeed be removed. Typically, this action involves local authorities, who will act upon complaints and may even issue orders for the removal of non-compliant installations. Since the 2016 edition of NFPA 1, access pathways have been required on roofs to facilitate fire service access as well as egress. Unfortunately, some states make this harder to achieve with restrictions on solar energy and its financing. Paradoxically, the states most likely to do this are some that would greatly benefit from solar power, like Oklahoma, Kansas, and Nebraska. “ROOF ASSEMBLY”<sup>1</sup> is a system designed to provide weather protection and resistance to design loads. 
