Overview

These tariffs average 37% on imported solar panels and 47% on lithium-ion batteries, affecting both commercial and residential energy sectors. The US Commerce Department set final countervailing and anti-dumping duty rates on Monday for crystalline solar cells and modules imported from four southeast Asian countries. Cells and modules from Vietnam, Malaysia, Thailand and Cambodia are affected. Importers have already been posting cash. A solar tariff is an additional fee or tax that a country charges on various types of solar power equipment imported into its borders by manufacturers that are based in another country. Often this is added to solar modules (panels), module components, and the raw materials needed to make modules. US solar panel imports declined 13% in 2024 amid harsh tariffs. International Trade Administration (U. Trade policies such as antidumping and countervailing (AD/CV) duties aim to protect domestic industries from unfair foreign trade practices, such as selling products at below normal value. In early April 2025, the United States enacted sweeping “reciprocal tariffs” on imports, aiming to mirror (at a discounted rate) the trade barriers faced by U. 
