The Rural Energy for America Program (REAP) offers federal grants and loans to help farmers and rural small business owners go solar, covering up to 50% of total project costs. Guaranteed loans may be accepted and compete on an on-going basis in accordance with 7 CFR 5001. Department of Agriculture announced sweeping changes to renewable energy funding this week, fundamentally reshaping access to federal solar incentives for rural America. The new rules eliminate USDA support for large solar farms on prime farmland and ban foreign-manufactured panels in all.
